RE: Year 8 Residential – PGL Cleethorpes Court, Lincolnshire

We are delighted to offer Year 8 students the opportunity to attend a residential trip at PGL Cleethorpes Court in Lincolnshire. This is an exciting three-day, two-night character developing experience, designed to grow confidence, build resilience and boost independence.

Throughout the trip, students will take part in a variety of adventurous outdoor activities including:

- Abseiling
- Climbing
- Canoeing
- Team challenges and problem-solving activities
- Evening entertainment and group events

Activities will be led by DBS-checked PGL staff, experienced in delivering safe and engaging outdoor education, supported by school staff.

The cost of the trip has been highly subsidised and will cost **£115** for all the activities, travel and food. However, your child will be required to bring a packed lunch for the Wednesday. If your child has free school meals a meal can be requested on the attached consent form.

This payment is to be made via Parent Pay and deposit to be received by **Friday 27 February 2026**. Places on the trip will be allocated on a **first come, first served basis**. When you access Parent Pay you will notice the following instalment schedule:

27/02/26 - £40 This initial payment is required to secure your child's place
27/03/26 - £40
30/04/26 - £35

For the residential, students will need to bring:

- pillow and sleeping bag / duvet
- weather-appropriate outdoor clothing (layers, waterproofs, sturdy footwear)
- comfortable clothes for evening activities
- personal items such as toiletries, towel, water bottle

There will be a pre-trip parent meeting on **Monday 18th May 2026 at 4pm**. A more detailed kit list will be provided at this time.

It is Academy policy that if a student misbehaves in the Academy his/her place on a trip will be withdrawn. The final decision on who goes on a trip is at the discretion of the Executive Principal and her decision is final. As we will travel by coach, no items should be left on the coach.

If you wish for your child to attend, please pay the deposit and return the completed consent form to the year team or reception by **Friday 27 February 2026**.

We are confident this residential will be both educational and memorable for students.
